**For SEG members, page charges of \$100 per page are voluntary for the first 10 pages.** Charges for pages in excess of 10 are mandatory at the rate of \$150 per page. **Effective 15 May 2009, charges of \$450 per color page are mandatory, except for Case Histories.**

Page and color charges are a significant source of income to GEOPHYSICS and are important to the financial success of the journal. Although failure to pay voluntary charges will not prejudice acceptance of a paper, the Society expects each author to make every effort to pay.
