Page and color charges are important aspects of GEOPHYSICS' financial support. Declining to pay voluntary charges will not prejudice acceptance of a paper; however, the Society expects authors to pay these charges if it is within their means to do so. Page and color charges for papers are mandatory if none of the authors is an SEG member in good standing.

GEOPHYSICS is a hybrid open-access journal. If authors pay all voluntary and mandatory charges, they can make their papers freely accessible indefinitely in GEOPHYSICS' online archives by selecting the appropriate open-access option and paying a US\$2,500 fee.
