Re: Required Affidavit to Accompany Scholarship Application

In order to comply with current SEG Foundation policies, in connection with current regulations outlined by the United States Office of Foreign Asset Control, all scholarship recipients who are not United States citizens are required to complete and sign the attached affidavit.

This affidavit requests that the scholarship recipient attest that the monies received from the SEG Foundation will not be used to support any terrorist activities, terrorist groups, or any persons currently linked to terrorist organizations as defined by various government (U.S. and non-U.S.) agencies.

This affidavit requires that your signature be verified by a notary public with an unexpired commission. This person may be located at your university or at any government agency. You may also have your affidavit signature witnessed by a SEG Student Section President or a recognized government official. If you have a question about who to have notarize/witness your signature, please contact our office.

It is required that you return this signed affidavit to our office to be eligible to receive scholarship funding.

4. The undersigned swears and affirms that it has no contact with entities or individuals who are otherwise known by the undersigned to engage in or support terrorism.
5. The undersigned agrees that the monies received will only be used in the context the money was intended, i.e. educational purposes at the designated university in the scholarship forms.
